BIO

Fernando Collantes is Professor of Economic and Social History at the University of Oviedo (Spain). He has held posts at the universities of Cantabria and Zaragoza, as well as visiting positions at the universities of the Italian Switzerland and Lund.

His major lines of research are: (1) the transformation of food consumption in affluent societies, taking Spain as a study case; (2) the depopulation and development of rural areas in Spain and Europe during the modern period; (3) the history of the European Union's Common Agricultural Policy from its beginnings in 1962 to the present day; (4) the history of economic thought regarding consumer society.

His research has been published in leading journals (such as the *Economic History Review*, *Agricultural History*, *Agricultural History Review*, *Business History*, *Rural History*, and the *Journal of Agrarian Change*, among others). He is the author of five books, among them three in English: *Milk in Spain and the history of diet change: the political economy of dairy consumption since 1950* (2024); *The political economy of the Common Agricultural Policy: coordinated capitalism or bureaucratic monster?* (2020); and *Peaceful surrender: the depopulation of rural Spain during the twentieth century* (2011, with Vicente Pinilla). He is currently working on a book provisionally entitled *Consumer society and the economists: consumption and well-being in the history of economic thought*.

Collantes' research has received numerous awards, including both the best article and the best book prize of the Spanish Economic History Association and the young scholar prize

of the European Association for Evolutionary Political Economy. He has been appointed for board positions in various international journals (such as *Agricultural History* and *Historia Agraria*) and academic societies. He has regularly organized sessions and presented papers at international conferences.

His outreach activities included the creation of *Todo comenzó ayer* (*Everything started yesterday*), the bi-weekly podcast that he created for the Spanish Economic History Association in 2021 and directed until 2024.
